

RIGHT OF WAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of One Dollar (\$1.00) and other good valuable consideration paid to L.D. & LIZA J. McCLOUD, hereinafter referred to as GRANTOR, by the TOWN OF MONTEREY, hereinafter referred to as GRANTEE, its successors and assigns, the receipt of which is hereby acknowledged the GRANTOR does hereby grant, create, and establish unto the GRANTEE a perpetual easement over, across, and through the land of the GRANTOR situated in the TOWN OF MONTEREY, PUTNAM COUNTY, Tennessee, as described in Exhibit "A" which is attached hereto and incorporated herein.

The grant and other provisions of this easement shall constitute a covenant running with the land for the benefit of the GRANTEE. GRANTOR also gives GRANTEE right of ingress and egress over the adjacent land of the GRANTOR, their successors and assigns, for the purposes of this easement.

IN WITNESS WHEREOF, the GRANTOR has executed this instrument the 11th day of January, 1993.



A permanent easement fifteen foot (15') wide for the construction, operation and maintenance of a sanitary sewer line, the centerline of said easement being described as follows:

Beginning at a point on the southern boundary line of said property, said point also being southwest approximately 7.5 feet from the common boundary corner of said property, the Geer property and the Blaylock property; thence north 57°00' west approximately 220 feet to a manhole; thence north 23°00' west approximately 90 feet to a point where the easement exits said property, said point also being northwest approximately 80 feet from the northwest boundary corner.

In addition to the above described permanent easement the grantor also agrees to allow a ten foot (10') wide temporary construction easement running parallel to the western boundary of the above described permanent easement, excluding any permanent structures.
