The lands herein conveyed are restricted to use and occupancy by the following protective covenants:

- 1. All lots are to be used for residential purposes only.
- No structure shall be erected, altered, placed or permitted to remain on any lot other than one single family dwelling.
- 3. All buildings must be located at least 40 feet back from the fronting street and shall be located at least 25 feet back from any street and at least 15 feet from any lot line.
- 4. No illegal or offensive activities shall be carried on upon any lot.
- 5. No hogs, cattles or chickens shall be kept upon said lots.
- 6. No house trailers or detached toilets shall be placed or erected upon said lots.
- 7. No temporary structures or partially completed buildings shall be used as residences.
- 8. No dwelling shall contain less than twelve hundred cocrax square feet of living area, which shall be in addition to all area used for carports, garages and semi-detached storage space and said minimum living area must be on the ground floor of said dwelling.
- 9. Asbestos shingles shall not be used as the exterior covering or siding or part of the exterior covering or siding of any residence constructed or placed on the lots herein conveyed and no exposed concrete blocks shall be permitted either in the foundation or otherwise in the said building.
 - 10. All residences shall have a continuous foundation.
- 11. These restrictions shall be covenants running with the land and shall be binding upon the grantees herein, their successors, heirs and assigns and shall be in force for a period of 30 years from and after September 30, 1972.
