- A. All lots to be known as resident lots.
- B. No structure shall be erected, altered, placed, or permitted to remain on any lot other than one detached single family dwelling, or one semi-detached two family apartment dwelling, not to exceed two stories in height and private garage have not more than two cars and other out buildings incidental to residential use of the plat.
- C. No Building to be located nearer to the front lot line than 40 feet; or side lot line than 10 feet, and building, garage or carport to be not nearer than 5 feet.
- D. No noxious or offensive trade or activities shall be carried on unon any lot.
- E. No temporary structures used as a residence.
- F. No dwelling to have less than 1200 square feet over all foundation.
- G. All building specifications to comply with Federal Housing Authority minimum requirements.

I. All residences built or constructed on any of the above lots be constructed of brick, stone, aluminum, or cedar shakes, and no exposed concrete block foundations to be permitted, and all residences built on the above restricted lots to cost the minimum of eighty-five hundred dollars (\$8500.00).

## AMENDMENT OF RESTRICTIONS

WHEREAS, on the 14th day of April, 1961, D. S. Roberts and wife, Neva Jane
Roberts, and Walter Dietz and wife, Lois Dietz, who were at the time the numers of
all the lots in the Eastwood Subdivision to Putnam County, Tennessee, executed an
agreement setting forth certain protective covenants to restrict the use and occupancy
of the lots in said subdivision, and

WHEREAS, dertain of said lots have been sold, and the undersigned hereto are the owners of all the lots in said Eastwood Subdivision to Putnam County, Tennessee, plat of which is recorded in the Register's Office of Putnam County, Tennessee, in Volume 81, page 605, and

WHEREAS, it is believed desirable and advantageous that certain restrictions be changed or amended,

IT IS, THEREFORE, MUTUALLY AGREED by and between the parties hereto that the said restrictions shall be amended in the following respects:

- 1. Section F shall be amended to read as follows:
  "No dwelling to have less than 1200 square feet overall foundation, provided, however, that this limitation is a limitation of overall dimensions, and the 1200 square feet may include a carport for not more than one car or a garage for not more than one
- 2. Section I of the said restrictive agreement is amended to read as follows: "All residences built or constructed on any of the above lots are to be constructed of brick, stone, aluminum, cedar shakes, or masonite, and no exposed concrete block foundations are permitted, and all residences built on the above restricted lots are to cost a minimum of \$8500.00."

We hereby ratify and affirm all the previsions, conditions and limitations contained in said restrictive agreement of April 14, 1961, as the same are amended hereby.
